**\*\*\*Please contact Duc Nguyen at the show to arrange disposal of water.\*\*\***

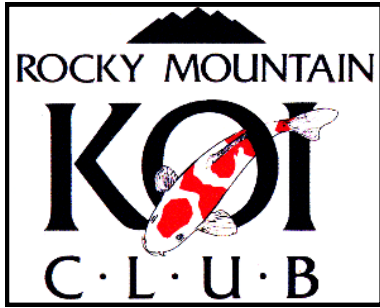
As with all koi shows tank space, vendor space, and hotel rooms at the Koi Show rates are limited. Please reserve soon.

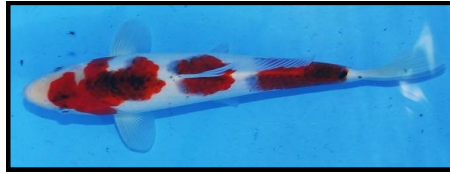
